Call to order 7:00 pm

Jim Donze, Bob Palmer, Mark Wiegert, Dave Evelsizer and Mark Basler were in attendance.

## **Open Forum:**

Mark Basler introduced guest speakers from DNR Erin Heidolph, Joe Clayton and Christy Savage Sparks. Mark told those in attendance that the DNR representatives were here to try and explain were Lake Forest is with the issue of compliance with the sewer system. Mark also introduced Rich Cochran from Waters Engineering who has been our engineer for a very long time.

Mark also explained that after the meeting we needed 50 signatures to move forward with the creation of the Sewer District. Those signatures were notarized by Don Kuehn as per the requirement.

Erin Spoke and went through slides which should be on the Lake Forest website and explained the history starting in 2006 and how Lake Forest failed to meeting ammonia requirements. Worth noting is that we are currently served with two fines, one for pollution discharge and the other for being out of time compliance. Each fine is \$10,000, MODNR will suspend both fines if we comply with our project time line completion. If we do not comply with MODNR they can find us an additional \$10,000 per day per violation.

There were many questions asked by those in attendance with a variety of questions. Please watch the video on the Lake Forest website which is a complete record of this meeting.

Rich Cochran from Waters Engineering spoke and explained his background, how the TMDL works, and what Lake Forest's plan is for moving forward in terms of meeting the requirements.

Treasurers Report- Bob Palmer

As of February 28, 2019, we had \$234,497 in our checking accounts and \$338,122 in certificates of

deposit. Our loan balance was \$256,147.

Income for the first month of the fiscal year was \$192,053. Expenses were \$18,215, resulting in net

income of \$173,838. Most of the income is from yearly assessments.

Water Usage – Well #1 pumped 604,000 gallons and Well #2 pumped 570,700 gallons for a total of

1,174,700 gallons. Wells and chlorinators are working properly.

Lagoons – Lagoons are normal. Blowers and new diffusers working properly.

Maintenance – This month we had a couple more snow/ice issues that had to be dealt with. Hopefully

that is about over. Cut down a hauled off and dead ash tree by the pond. We have also been cleaning

up wood piles left by Townsend last year. Townsend is back working on leftover missed trees for

Citizens Electric. The warning siren was serviced last week. Batteries were replaced along with a few

blown fuses. The parcel lockers got repaired when we are made aware of it. If you are expecting packages, please check daily until you receive it to keep the boxes freed up.

We plan to place a fish order for the two smaller lakes this year as promised this month. As you may recall the MDNR recommended we stock with larger fish to minimize the mortality rate caused by the high bass populations in the lakes. Lake Anne will not be stocked this year until we know more about the sewer line and dredging project timeline.

As promised, based on feedback from last year I have ordered two channel buoy "balls" to help guide boaters out of the marina towards the deepest part of the channel due to shallow areas. These will be installed with the normal buoys before Memorial Day Weekend and possibly sooner weather permitting.

John Summers has volunteered to work with Jim Donze on a design for some steps down at the marina on the pavilion side. More to come in future updates.
