A: In order to meet the MO DNR requirement for our wastewater system upgrade, we needed to secure a loan through the USDA. The monthly payment to the USDA and required sub accounts equal out to \$82.00 per month per LFE address (per the USDA). We need to fund these accounts and be ready for our sweep payments by the end of the project. The Board

decided to increase at increments of \$18.50 per month, per year until all residents are billed at the \$82.00 per month.
