As of November 30, we had \$205,390 in our checking accounts and \$229,234 in certificates of deposit.

For the ten months ending November 30, total income was \$353,673. Expenses for the same time period were \$211,152, resulting in net income of \$142,521.

# Community Managers Report: Tom Duro

Most of the mowing and leaf mulching and burning are done. Dump truck has been repaired by Barley Automotive. It needed a new sending unit and switching pump at a cost of \$786.44. We have been working with Aptitude and Ervin Cable Co to minimize damage to property. We are starting to get things winterized and get equipment ready for snow removal. Community center vestibule and Frontenac Room have been painted. CWD and LFE drop boxes have also been installed in the vestibule and a new CWD info board and an LFE community board will be located there, soon. There is no longer a dropbox or bulletin board in the post office. Please do not use the post office as a drop off or share location. New lockers have also been installed at the post office to help you get your packages more efficiently. Please do your part in picking up packages the day you receive them, so the locker can be utilized the next day. If lockers are not available for packages, the mail carrier will take packages back to the post office in Ste. Genevieve, and you will have to go there to pick up your package.

### **Committees:**

Public Works: Don Kuehn

There is one remaining street sign and post to be installed. The new signs and post are looking good. Tom and John have done a great job getting those installed.

**Planning and Finance**: Kent Orrick

The committee had met and presented their recommended 2022 budget to the Board. The Board will take action on this at the next Board meeting.

**ACC:** Todd Donze

There are permits for 3 Boat Slips are under construction. As a reminder on January 31, 2022 the valve to Lake Anne will be closed. The water level can rise very quickly depending on rainfall. Any construction dependent on the lake being lowered will need to be completed by then.

**Lakes:** Chuck Easley/Ray Joggerst

The no wake buoys have been removed from Lake Anne for the winter season. Two orange channel markers were placed at the mouth of party cove but none in the marina area as that part of the lake will be unnavigable while the lake is lowered for seawall/dock work. Thank you to Wayne Basler for his assistance with that project.

We submitted a bid to the board for a floating courtesy dock for the marina launch area. The bid is for a dock that would be 20 feet long and 6 feet wide, running parallel with the bank, just north of the launch ramp.

We reviewed the 2018 electrofishing survey done by the MDC. That survey showed Lake Anne has an overabundance of small, mature bass which will never reach a desirable size and MDC recommended these smaller fish be harvested. Therefore, we recommend returning to a slot limit next year for bass. We are recommending a 12-15 inch protected slot.

There are several boards in the marina area that are either missing or broken/damaged and need replaced. We would like to replace them before next spring.

This spring, we will be holding a free will pancake breakfast in support of the annual kids fishing day.

We are also gauging interest in a Lake Forest fishing tournament that would be held on Lake Anne.

We would like to get a better boat launch on Lake Marion and that is being looked at.

There was discussion about more boat slips at the Marina and the Board continues to look a solution.
