We plan to stock fish again this year and will be contacting our supplier to get a quote and arrange

delivery.

past couple of weeks but continue to keep the traps out as we don't believe they have left for good.

We also would like the board to consider adding a road through the picnic area in the future and

refinishing/resurfacing of the picnic tables, which are showing a lot of wear. The proposed road would

be a single lane, one way route and would allow easier access to the various picnic tables within the

public area and the lake itself.
